TOP 10 – Wahl des Tagungs- ortes und Bekanntgabe des Termins des Bayerischen Ärztetags im Herbst 2012

Auf Beschluss des 69. Bayerischen Ärztetags findet der 70. Bayerische Ärztetag vom 14. bis 16. Oktober 2011 in München statt. Im Jahr 2012 wird der Bayerische Ärztetag vom 12. bis 14. Oktober in Augsburg abgehalten.

Dear Madam Chancellor Merkl, dear Federal Ministers Westerwelle and Rösler,

what I hear and read in the german TVs, radios and newspapers is not at all nice. I'm not amused, really! Citizens, insurants of the Legal-Illness-Cashieres, will pay in 2011 higher contributions and even in 2012 higher add-on-contributions.

This, although you, Minister Westerwelle, have promised bevor the elections: „More net from the gross!“ And you all have promitted, too, less taxes and contributions in general. And now? The opposite is the case. This is total no-go-policy! Why this policy brings me on top of a palm? Because the effects of the sanitary reform will very quickly go up into smoke.
